Conditions of Showing

- General regulations as per Goulburn Show Society
- Stud Classes open to Fullbloods registered with BGA or BGBAA
- **Registration Papers to be available if requested on arrival**
- Animals to be free of external parasites/lice & must not have any bald or open abscesses. Inspection on arrival.
- Animals must remain on grounds until completion of Judging on Sun 8th March 2020. Unless by special arrangement with the approval of the Administrators.
- Classes may be altered depending on numbers of entries
- Limited space available for safe penning & exhibiting – Once area full entries may be declined or asked to reduce numbers.
- Age to be calculated from day of show 7th March.
- No Stud insignia to be worn/visible in ring during judging. Tidy clothing with closed in shoes. White coat optional.
- All exhibits must have NLIS compliant tag & individual ID tag.
- Red/Black/Paint & Commercial Classes with less than 3 entries will be merged with an adjoining class or sectioned cancelled.
- Any Red/Black, Paint or Commercial Class with greater than 6 entries will be considered to add a Class as feasible.
